#### **RESOLUTION NO. 21-962**

A RESOLUTION of the Port of Ilwaco, a municipal corporation, located in Ilwaco, Washington, establishing an airport advisory committee, known as the Port of Ilwaco Airport Advisory Committee.

WHEREAS, the Port of Ilwaco owns and operates a general aviation airport (7W1), as designated by the Washington State Aviation System Plan (WSASP); and

WHEREAS, the Port of Ilwaco has continuously operated and maintained the airport facility since 1971; and

WHEREAS, the Port of Ilwaco airport is the only airport in South Pacific County, serving both local residents and visitors from outside the area; and

WHEREAS, the Port of Ilwaco desires to have an Airport Advisory Committee (AAC) to advise the Port Commission on specific topics assigned to the committee directly related to the Port of Ilwaco airport; and

WHEREAS, the AAC serves to provide a forum for input from both licensed aviators and the community on subject(s) assigned to the AAC from the Port Commission, which may include technical input, safety considerations and a community perspective, including airport operations, development, community partnerships, services and impacts; and

WHEREAS, the Port of Ilwaco has an airport master plan on file and will be used as reference for the AAC to assist in advising the Port Commission on the specific topics as may be assigned; and

#### NOW, THEREFORE,

BE IT RESOLVED by the Port Commission of the Port of Ilwaco, Washington, that:

1. The Port of Ilwaco Airport Advisory Committee:

The Port of Ilwaco Airport Advisory Committee ("Committee") is a Committee of local citizens in south Pacific County selected through an application process determined by the Port of Ilwaco Commission ("Commission"). The purpose of the Committee is to provide guidance to the Commission on tasks as assigned by the Commission.

#### 2. Composition:

The Committee shall consist of up to 5 and no less than 3 members selected by the Commission. A Port Commissioner and alternate Port Commissioner, as determined by the Commission, may also serve on the Committee.

#### 3. Duties:

The Committee shall advise the Commission on matters assigned by the Commission. It shall forward written, unsolicited public input received by the Committee members to the Port Manager who will determine how such unsolicited input shall be handled.

#### 4. Assignments:

When the Commission decides to seek advice from the Committee, the Commission will meet with the Committee to discuss the scope of the assignment. This meeting will be held in accordance with RCW 42.30 (Open Public Meetings Act).

#### 5. Work Plan:

The Committee shall develop a work plan consistent with the assignments provided by the Commission.

#### 6. Rules and Regulations:

The Committee must consider any and all federal, state and local rules and regulations applying to the management of general aviation airports when advising the Commission on an assigned topic.

#### 7. Scheduled Meetings:

The Committee will establish a meeting schedule consistent with the time necessary to complete a work plan and the assignment. The chair of the Committee shall report periodically to the Commission. All meetings and documents created by and for the Committee are subject to the Open Public Meetings Act Chapter 42.30 and the Public Records Act Chapter 42.56 RCW.

#### 8. Community Involvement:

The Committee shall have the authority to solicit public involvement consistent with the work plan.

All of the Committee scheduled meetings will be open to the public. A portion of the Committee's scheduled meetings will be designated for public comment related to the Committee assignment(s) and consistent with the time limits adhered to at regularly scheduled Commission meetings. The Chair or acting Chair should promptly direct any other public comment that is not related to the Committee's assignment(s) to the Port Commission or Port Manager via the most expedient means such as e-mail or telephone.

#### 9. Rules of Procedure:

Roberts Rules of Order shall be followed at all times during the public meeting.

Attendance of committee members present and anyone in attendance during the meeting will be recorded.

A committee member will take minutes. Such minutes will be approved by the committee and, upon approval, be provided to the Commission and kept on file in the Port office.

#### 10. Officers and Committee:

There shall be a Chair and a Vice Chair to preside and facilitate presenting reports, and such other offices, or subcommittees as the Committee deems appropriate. The Chair and Vice Chair shall serve one-year terms. The Chair and Vice Chair shall be voted on by the Committee; however the Commission reserves the right to appoint the Chair and Vice Chair, at the discretion of the Commission.

The Port shall supply administrative support to publish the notice for scheduled meetings, to assist the Committee with minutes, recording discussion items, scheduling meetings and other duties as agreed to by Port administration and the Committee.

#### 11. Terms:

The initial Committee members shall each serve a 24 month term. The Commission, upon its sole discretion, may appoint or re-appoint Committee members to carry forth assignments as may be needed in the future. If there is not an established Committee for a period of time (after the initial 24 months), the Commission can re-establish a new Committee at any time by following these initial procedures.

#### 12. Conduct of Committee Members:

Committee members serve at the discretion of the Commission, and as such, it is expected that each Committee member conduct Committee related business in an

open, respectful and courteous manner, when participating in committee meetings or any related activities. Harassment and/or Bullying by a Committee member, or members, is unacceptable conduct and may result in dismissal and removal of the member from the Committee, upon consent of the Commission.

#### 13. Selection of New Members:

The process to select new members will consist of a legal notice in local newspaper (*Chinook Observer*) advertising the vacancy and recruitment process. The interview team will consist of a Port Commissioner and the Port Manager and the current Chair of the Committee.

The Port will develop a uniform basic application for interested citizens to complete.

The interview team will interview and evaluate each applicant based on private/public work experience, experience or knowledge regarding the Port of Ilwaco Airport, experience with aviation and/or aircraft and representation within the Port of Ilwaco Port District. Anyone applying should identify the reason(s) for wanting to serve on the Committee. After completion of all applicant interviews, the Commissioner serving on the interview team will recommend appointment of the new member(s) at a regularly scheduled Port Commission meeting. The Port Commission shall vote to affirm the final selection of a Committee member(s).

**PCOG Grant Reallocation** 

The Port was awarded \$65,000 from PCOG in 2019 to complete preliminary engineering for modernizing the Travelift pier and related bulkhead at the boatyard.

Approximately \$16,450 of this work has been completed to date, which included a site assessment and alternatives analysis. Further work on investigating alternatives for the project can be delayed and the remaining \$48,550 of PCOG grant funds could be re-allocated to fund similar engineering and permitting needed on the Safe Coast Seafoods "East Bulkhead Renewal" project.

I have notified PCOG of our interest in this reallocation and they are adding it to their August 11<sup>th</sup> meeting agenda for approval.

I would like to have a formal motion be approved at our August 5th meeting to reallocate the funds as I have described above, pending PCOG's approval on August 11th.

The Community Economic Revitalization Board (CERB) is authorized by chapter 43.160 RCW to provide funds to political subdivisions to assist in financing the cost of certain public facilities. This Initial Offer of Financial aid is contingent upon the availability of CERB funds. CERB hereby offers to make funds available to the **Port of Ilwaco**, hereafter referred to as the "Contractor," in order to aid in financing the cost of, or improvements to, public facilities consisting of **Port of Ilwaco Bulkhead Replacement** as described in the application (hereafter collectively referred to as the "Project").

This offer consists of:

- General Obligation loan of \$637,500
- Interest rate: 2.5 percent (%) per annum on the outstanding principal balance
- Term: 20 years maximum
- Grant of \$112,500

This offer is subject to completion of pre-contract conditions, as described in Attachment A.

A final contract shall be developed by CERB prior to disbursement of funds. No project costs incurred prior to this offer date will be reimbursed by CERB. In the event a final contract is not executed, no CERB funds will be disbursed.

If accepted, this Initial Offer of Financial Aid must be signed and returned to CERB by August 27, 2021
